OVERVIEW:

The SADC Development Finance Resource Centre (DFRC) with the financial support of the European Union is pleased to announce the hosting of a programme on director skills development for board members and senior management of development finance institutions (DFIs) in Africa and their select stakeholders. The programme will be held at Protea Waterfront Hotel in Centurion, Pretoria, South Africa on 28th May to 8th June 2012.

The programme was initially developed by the SADC DFRC with the technical assistance and support of the Global Forum for Corporate Governance, Washington D.C. As a supporter of the Pan African Consultative Forum on Corporate Governance and the SADC-DFRC, it initiated a capacity building and technical assistance project for development of a corporate governance and director development programme to institutionally strengthen the DFI network within the SADC – DFRC and subsequently other regions and clients of DFIs.

The project was perceived as of strategic importance for the larger goals in the SADC region to be achieved through skills enhancement and advanced techniques in directing DFIs.

The programme is funded under European Development Fund no.9 for the implementation of Finance and Investment Protocol of the Treaty of the Southern African Development Community, The development finance component deals with capacity building for development finance institutions and the establishment of SADC Development Fund.

OBJECTIVES:

The purpose of the programme is to raise awareness of the concept, practice and relevance of good corporate governance in the context of development finance institutions and the challenges they face within the African landscape. The programme will also provide the opportunity for serving directors to improve their skills in the boardroom through a practical and interactive approach that involves case studies, group work and discussions, as well as the prospect of sharing experiences with directors on DFI boards from other African countries. In addition, the second part of the programme will provide scope for development of customised approaches to corporate governance for the SME sector, potential integration of these in financing of SMEs, possibilities of leveraging on corporate governance strategy for growth by SMEs and developing leads for action plans on incorporating these.
